PW(R&B)NG/124/2019 dated 30.09.2020 and PW(R&B)NG/124/2019 dated 17.12.2020 for the post of "**Draftsman"** (Civil) Public Works (R&B) Department UT Cadre, the advertisement notification in respect of the said post was issued by the Board vide Notification No. 05 of 2020 dated 24.12.2020 under Item No. 132 with following category wise breakup: -

The qualification, as per the Notification No. 05 of 2020, prescribed for the posts of Draftsman Civil in Public Works Department is as under:

Two Years Draftsman Training Course Certificate/Diploma in Civil Engineering from Government recognized Institute".

Subsequently, the Public Works Department vide letter No. PW(R&B)/NG/124/2019 dated 29.12.2020 intimated that typographical error occurred in the column mentioning qualification/indent for the post of Draftsman Civil and Draftsman Mechanical in the aforesaid indent and that the actual qualification for the post of Draftsman (Civil) and Draftsman (Mechanical) is as under:

"Two Years Draftsman Training Course Certificate/Diploma from any Government recognized Institute".

The Jammu and Kashmir Services Selection Board vide No. SSB/Secy/Advt.No./2021/228-243 dated 11.01.2021 issued corrigendum to the aforesaid advertisement notification No. 05 of 2020 to the effect that the prescribed

qualification for the post of Draftsman Civil UT cadre under Item No. 132 shall be as under:

"Two Years Draftsman Training Course Certificate/Diploma from any Government recognized Institute".

In pursuance of the aforesaid amendment in the advertisement notification No. 05 of 2020, the qualification prescribed for the posts of Draftsman Civil for both the Departments as mentioned in the respective Indents/ subsequent Advertisement Notifications comes to be as under:

"Two Years Draftsman Training Course Certificate/Diploma from any Government recognized Institute".

The criteria adopted by the Board for making selection to the post of Draftsman Civil was also notified in the Advertisement Notifications as under:

The selection for the posts shall be made on the basis of merit obtained in written examination only.

As per the criteria adopted for the post, the Jammu and Kashmir Services Selection Board conducted Computer Based Test (CBT) for selection of candidates w.e.f 27.10.2021 to 02.11.2021 & 08.11.2021 to 12.11.2021 in multiple shifts/sessions and the result of the said examination was declared vide Notification No. SSC/COE/CBT/2021/8929-36 dated 20.12.2021.

On the basis of merit obtained in the result, the candidates falling within the consideration zone were called for document verification vide Notice No. SSB/SOE/CBT/2022/211-18 dated 08.01.2022. A Selection Committee was constituted by the J&K Services Selection Board vide Order No. 30-SSB of 2022 dated 28.01.2022.

Since, the combined written examination was conducted for all the cadres for the posts of Draftsman Civil, the Jammu and Kashmir Services Selection Board sought online preferences from the candidates from 09.02.2022 to 11.02.2022 in respect of notified cadres, so as to consider only one candidate for single post in accordance with merit cum preference method, and thus create situation for filling of maximum post, requisitioned by the Indenting Department.

The Selection Committee in accordance with the rules governing the subject and following the principle of merit-cum-preference prepared a Provisional Selection List of UT Cadre posts of Draftsman Civil under Item No. 132 and the said provisional list was notified vide Notification No. SSB/Secy/Sel/2022/1623-32 dated 23.02.2022. It was also notified in the Provisional Selection List that the candidates can submit their grievances/representations, if any, alongwith documentary Oevidence against the said provisional selection list from 23.02.2022 to 27.02.2022.

Subsequently, the selection list prepared in light of the criteria adopted by the Board under relevant rules and on the basis of merit obtained by the candidates, was approved by the Board in its 199th Board Meeting held on notified vide No. the said selection list was 09.03.2022 and SSB/Sel/Secv/2022/2885-90 dated 19.03.2022 (A copy of the aforesaid notification is enclosed for reference).

Accordingly, the approved selection list alongwith waiting list for the post of Draftsman comprising 33 candidates (OM=18, SC=03, ST=03. OSC=01, ALC/IB=01, RBA=04 and EWS= 03) alongwith waitlist of 18 candidates (OM=09, SC=01, ST=02. OSC=01, ALC/IB=01, RBA=02 and EWS= 02) categories of enclosed as Annexure "A" of this communication. However, 01 post under PSP category has been kept unfilled for want of certain clarification.

The Selection List as mentioned above shall be subject to outcome of the writ petition (s) (if any) pending disposal before any competent Court of jurisdiction related to the selection.

The document verification/ scrutiny conducted by the Board is limited to the extent of establishing physical possession of category/degree and ascertaining genuineness/validity etc. or otherwise of the same and recognition status of the Institution, shall be responsibility of the Indenting Department/appointing authority.

It is further requested that in case any certificate/document, during the course of verification, turns out to be fake/fictitious, the Board may kindly be kept posted and appropriate criminal proceedings against such candidates may kindly be initiated.

The selection list is also available on the website of the J&K Services Selection Board (www.jkssb.nic.in) and may be cross verified from it, if required.
