- 2. Applicant must be a Domicile of the Union Territory of J&K and resident of District Baramulla.
- 3. Applicants should be medically fit for field visits in different blocks / villages of District Baramulla.
- 4. The engagement being a temporary/confectual arrangement is terminable if the perform is not satisfactory as assessed by the Listrice Level Committee headed by the Listrice Level Committee headed by the Magistrate/District Development Commissioner.
- 5. There shall be no right to seek permanent absorption in any department or regularization of any sort (Agreement for the same sworn before judicial Magistrate 1st Class needed to be executed upon selection before joining).
