



immediately, otherwise disciplinary action shall be initiated against them as warranted under rules;

AND WHEREAS, these doctor neither replied to notice nor reported back for duties;

AND WHEREAS, Rule 25 (2) of J&K Civil Services Leave Rules, 1979 prescribed as under:-

" willful absence from duty after the expiry of leave renders a Government servant liable to disciplinary action."




AND WHEREAS, Article 128 of J&K Civil Services Regulations Volume-I envisage as under:-

" Absence without leave or after the end of leave involves loss of appointment, except as provided in Article 203 (b) or when due to ill health in which case the absentee must produce the certificate of Medical Officer."

AND WHEREAS, the cases of these doctors have been examined thoroughly in the department in view of the rule position governing the subject and it has been found that since these doctors have not resumed their duties despite notices issued to them and this act on their part is a voluntary act and they are liable to be discharged from services on account of unauthorized absence from duties for more than five years.

Now, therefore, in terms of Article 128 of J&K Civil Services Regulation, Vol-I, the services of following Twelve (12) un-authorizedly absent doctors are hereby terminated and they are discharged from the Government service from the dates mentioned against each:-
