### Government Order No. 750 -JK(HME) of 2024 Dated: 08-11- 2024

WHEREAS, the Directorate of Health Services, Kashmir vide communication No. Est/3/1-133/4159 dated 28.04.2021 and Directorate of Health Services, Jammu vide communication No. DHS/J/Es-3/L-F/M.D01/520 dated 04.05.2021 provided the details of lien free vacancies of the Medical Officers including leave/training/deputation reserves;

AND WHEREAS, the aforesaid details of lien free vacancies of the Medical Officers including leave/training/deputation reserves were duly reconciled with actual strength and subsequent creation from time to time including transfer of vacancies to UT of Ladakh as well as to five new Government Medical Colleges and accordingly the Health and Medical HD/Gaz0Gen/47/2021-02 dated Department vide U.O No. Education 01.06.2021, dated 22.06.2021 & 20.09.2021 referred the issue to Finance Department for their concurrence with regard to referral of aforesaid vacancies to J&K Public Service Commission;

AND WHEREAS, the Finance Department vide their U.O. No. FD-Code/106/2021-03-980 dated 04-10-2021 conveyed its concurrence to the referral of 708 posts of Medical Officers, as per following breakup to J&K Public Service Commission for recruitment of suitable candidates, subject to certain conditions:-

AND WHEREAS, the Finance Department further advised that the Public Service Commission shall be requested to incorporate the following conditions in the Advertisement Notice to avoid any adverse orders from the competent Courts of Law in future:-

- The selectee(s) shall not be allowed to continue with PG/tenures of Senior Residency/ Registrarship/ Demonstratorship and they will have only one choice either to opt for selection or opt out and go for PG/tenures of Senior Residency/ Registrarship/ Demonstratorship.
- ii. The selectee(s) on appointment will have to work in peripheral and far flung areas of the Union Territory of Jammu & Kashmir.

AND WHEREAS, the Health and Medical Education Department vide communication No. HD/Gaz/Gen/47/2021 dated 18.11.2021 referred 708 (450 fresh + 258 Backlog) vacancies of Medical Officers of the J&K Health and Family Welfare (Gazetted) Service to the J&K Public Service Commission for making selection as per following category wise breakup and in the said communication dated 18.11.2021, it was requested to J&K Public Service Commission to incorporate aforesaid conditions as advised by the Finance Department in the advertisement notice to avoid any adverse orders from the competent courts of Law in future:-

AND WHEREAS, the Secretary, J&K Public Service Commission vide various communications forwarded the Select lists of (362) candidates under various categories against the posts of Medical Officers (Allopathic) in Health & Medical Education Department;

AND WHEREAS, on the basis of recommendations of J&K Public Service Commission (in whose verification report have been received from the JK CID), appointment orders in respect selectee candidates were issued by the department from time to time;

AND WHEREAS, the Secretary, J&K Public Service Commission vide communication No. PSC/MO/(Allo)/2023 dated 04.08.2023 has informed that 258 posts of various reserved categories remained unfilled out of the

notification dated 30.07.2020, which were advertised under 1st special drive vide notification dated 18.12.2021, out of this notification 198 posts of various categories again remained unfilled which were re-advertised under 2<sup>nd</sup> Special Drive vide Notification dated 17.01.2023. Out of the said 2<sup>nd</sup> Drive 163 posts of following reserved categories have again remained unfilled due to nonavailability of the candidates did not cross the prescribed bench mark:-

AND WHEREAS, the matter of de-reservation of these 163 Medical Officer posts was, accordingly, taken up with the Social Welfare Department for de-reserving them in terms of Section 5 of J&K Reservation Act, 2004 which vide U.O. No. SWD-BCC/11/2023 dated 12.09.2023 conveyed as under:

> "The department is advised to proceed ahead as per Section 5 of the Jammu & Kashmir Reservations, 2004 read with amendments made vide SRO 144 in Rule 7, Sub Rule (4) of Jammu and Kashmir Reservation Rules, 2005, as per the provisions in the said Act/Rules for filling up of reserved category posts which remained unfilled for last 3 years due to non-availability of candidates in relevant categories, subject the following conditions:-

> (i) If a sufficient number of candidates is not available from any reserved category during a recruitment process, the posts shall remain vacant and shall be carried forward to the next recruitment process;

> Provided that nothing herein contained shall prevent launching of a special drive by a selection agency to fill the carried forward vacancies by inviting applications exclusively from persons belonging to such category;

> Provided further that in respect of selection of candidates under the Jammu & Kashmir Migrants (Special Drive) Recruitment Rules, 2009, if the candidates are not available from any reserved category, other than those falling under sub-clause (i) of clause (o) of Section 2, the posts earmarked for any such reserved category may be filled up from amongst the eligible candidates in open merit category.

- (ii) If in the first attempt of recruitment, suitable candidates are not available, second attempt may be made in the same recruitment year and if even then suitable candidates are not available, the vacancies shall be treated as backlog vacancies.
- (iii) In subsequent year, when recruitment is made for reserved vacancies, the backlog vacancies shall also be notified;

Provided that the total number of reserved vacancies including backlog vacancies shall not exceed the percentage reserved for such categories.

(iv) The reserved vacancies remaining unfilled for a period exceeding three years shall be treated as de-reserved.

AND WHEREAS, on the basis of advice of the Social Welfare Department, the issue of de-reserving vacancies of Medical Officers was taken up with the General Administration Department which opined as under:-

"The department is advised to proceed in the matter in terms of the opinion conveyed by Social Welfare Department vide U.O No. SWD-BCC/11/2023 dated 12.09.2023. The department may also consult Department of Law, Justice and Parliamentary Affairs before proceeding further in the matter."

AND WHEREAS, the Department of Law, Justice and Parliamentary Affairs was also consulted which advised as under:-

"Department is advised to proceed in terms of advice of Social Welfare Department as conveyed vide U.O. SWD-BCC/11/2023 dated 12.09.2023."

AND WHEREAS, in pursuance of the advice of Social Department, General Administration Department and Department of Law Justice & Parliamentary Affairs and Section 5 of J&K Reservation Act, 2004 and Rules made thereunder, the Health and Medical Education Department vide communication dated 04.01.2024 referred de-reserved 163 posts of Medical Officers for advertisement and making selection of suitable candidates against these un-reserved vacancies as per the roster details with the condition that the succeeding un-reserved vacancies shall, on the next occasion of selection, be treated as reserved ones.

AND WHEREAS, the Secretary, J&K PSC vide communication No. PSC/DR/Medical Officer (Allopathic)/H&ME/2024 dated 10.06.2024, dated 25.06.2024 & 22.08.2024 has stated that Health and Medical Education Department vide communication dated 04.01.2024, referred 163 (de-reserved) posts of Medical Officer (Allophatic) in Health and Medical Education Department to the J&K Public Service Commission for selection under OM category.

AND WHEREAS, further commission notified the said posts vide notification No. 03-PSC (DR-P) of 2024 dated 05.03.2024. The written examination was conducted on 21.04.2024 and the merit list was issued vide notification No. PSC/Exam/S/2024/22 dated 07.05.2024.

AND WHEREAS, on the basis of overall performance of the candidates in the written test, the Secretary, J&K, PSC has recommended 163 (i.e 149+5+9 respectively) one hundred sixty three candidates for appointment as Medical Officer in Heath and Medical Education Department subject to the conditions stipulated by the J&K PSC:-

- The candidates have mentioned that they are the domicile of J&K UT and are within i. the prescribed age limit.
- The candidates shall be allowed to join only after scrutiny of all the original ii. documents/testimonials as required under rules.
- A copy of appointment order issued on the basis of this recommendation may be iii. endorsed to the commission for reference and record.
- The selection of the candidates is subject to the outcome of writ petition(s), if any, ίv. pending in any competent Court of law on the subject.
- The recommendation will remain valid for a period of one year from the date of communication sent to the Government. The validity period of one year can, however, be extended for a further period of six months on a specific request of the Government, if the request for such extension is made before the expiry of validity of the panel as per J&K Public Service Commission (Business & Procedure) Rules 2021, as amended up-to-date.

AND WHEREAS, as per the instructions of General Administration Department issued vide Circular No. 18-JK(GAD) of 2022 dated 20.05.2022, the character and antecedents verification of the selectees is to be obtained through Online Submission of Personnel Verification Rolls (PVRs) and consequently, the Health and Medical Education Department issued Notices to the concerned selectees through print & electronic media under endorsement No. HD-Gaz0Gen/272/2024-02- part file (E- 7504336) dated 24.06.2024 & No HD-Gaz0Gen/272/2024-02-Part file (E- 7504336) dated 02.07.2024 & HD-Gaz0Gen/272/2024-02-Part file (E- 7504336) dated 29.08.2024 for submission of their email address & mobile number in the Health and Medical Education Department, Civil Secretariat, Srinagar/Jammu for registration under "Employee Verification System (EVS)" within a period of 07 days positively from the date of issuance of these notices. It was also specifically mentioned in these notices that in case, any candidate, fails to submit his/her email address & mobile number within a prescribed period of 07 days, it shall be presumed that the candidate is not willing to opt for such appointment in Health and Medical Education Department and shall forfeit the right of appointment, without any further notice.

AND WHEREAS, the selectee candidates, who applied for registration and uploaded their details through Online Submission of Personnel Verification Rolls (PVRs) for their verification of character and antecedents, their PVRs were immediately forwarded through online portal to J&K Criminal Investigation Department for further course of action.

AND WHEREAS, in the meanwhile, few newly Medical Officers selected vide No. PSC/DR/Medical Officer (Allopathic)/H&ME/2024 dated 05.07.2024 have represented in the department stating therein that their

examination was held on 17.03.2024 and results declared on 03.04.2024 but their selection was forwarded to H&ME Department on 05.07.2024. Whileas, on the other hand, an another selection list bearing No. PSC/DR/Medical Officer (Allopathic)/H&ME/2024 dated 10.06.2024 was forwarded to the Health & Medical Education Department much earlier despite the fact that their examination and results were declared much later than their selection list and even their final merit list was also issued after their merit list was made public. This discrepancy in timing could potentially result in disputes concerning seniority between the two batches and as such, these selectees requested for clarifications of the issue;

AND WHEREAS, the same was taken up with Secretary, J&K Public Service Commission vide No.HD-Gaz0Gen/659/2023-02 (E. 7245197) dated: 06.08.2024 with the request to furnish comprehensive clarification on this matter, specifically, in respect of inter-se seniority between the two batches;

AND WHEREAS, the J&K Public Service Commission, vide communication No. PSC/M.O/Allop/2023 dated 08.08.2024 informed as under:-

> "...... that the said recommendation (communication No. PSC/DR/Medical Officer (Allopathic)/H&ME/2024 dated 05.07.2024) was forwarded latterly, after recommendation No. PSC/DR/Medical Officer (Allopathic)/H&ME/2024 dated 10.06.2024, due to some in-house clarifications. As a result, the recommendation in respect of posts advertised vide Notification No. 37-PSC (DR-P) of 2023 dated 10.08.2023 was forwarded later than that of Notification 03-PSC(DR-P) of 2024 dated 05.03.2024.

> It is reiterate that Notification No. 37-PSC (DR-P) of 2023 dated 10.08.2023 is the first one, and Notification 03-PSC(DR-P) of 2024 dated 05.03.2024 is later one. As such, Notification No. 03-PSC (DR-P) of 2024 dated 05.03.2024 will have precedence."

AND WHEREAS, thereafter in continuation to aforesaid communication dated 08.08.2024, the J&K Public Service Commission, vide another communication No. PSC/M.O/Allop/2023 dated 13.08.2024 conveyed as under:-

"...... to kindly read Notification 37-PSC (DR-P) of 2023 dated 10.08.2023 will have precedence instead of Notification 03-PSC(DR-P) of 2024 dated 05.03.2024 in the last line of the said letter."

AND WHEREAS, among aforesaid selectee candidates, who applied for registration and uploaded their details, the department received verification reports of character and antecedents from J&K Criminal Investigation Department in respect of 151 (one hundred fifty one) candidates till date:

AND WHEREAS, during the earlier process of recruitment of Medical Officers it has been observed that a substantial chunk of selectees are undergoing PG/Senior Residency/ Registrarship/ Demonstratorship at the time of their selection and as a consequence, such selectees often plead for permission to continue their higher study courses. These posts, though substantively occupied, physically/practically remain vacant, which in turn leads to public resentment as consequent crisis of non availability of doctors in the concerned health institution in the rural/ peripheral areas shall persist;

AND WHEREAS, taking cognizance of the aforesaid issue and in the interest of patient and health care, the State Administrative Council (SAC) vide its Decision dated 14/11/2018 has already decided that in future selections/appointments of Medical Officers, selectee Medical Officers shall not be allowed to continue with PG/ tenures of Senior Residency/ Registrarship/ Demonstratorship and they will have only one choice either to opt for appointment or opt out and go for PG/ tenures of Senior Residency/ Registrarship/ Demonstratorship etc;

AND WHEREAS, Rule 61 (4) (i) & (1) of the J&K Civil Services (Leave) Rules, 1979 read with S.O 234 dated 21.07.2020, which governs Study Leave, provides as under:-

- "(4) Study leave shall not ordinarily be granted to a Government servant:-
- (i) Who has rendered less than five year's service under the Government or till he/she, if probationer, does not complete the period of probation satisfactorily whichever is later.
- (1) Study leave shall not be granted to a Government servant with such frequency as to remove him from contact with a regular work or to cause cadre difficulties owing to his absence on leave."

Now therefore, as recommended by the J&K Public Service Commission, sanction is hereby accorded to the temporary appointment of <u>151</u> (one hundred fifty one) candidates (in respect of whom verification reports have been received from J&K Criminal Investigation Department) as Medical Officers in the Jammu and Kashmir Health and Family Welfare (Gazetted) Service in the pay scale, Level-9 (Rs.52700-166700), alongwith their postings, as indicated in Annexure-A to this order, with immediate effect, subject to the following conditions:-

A. The appointee(s) shall submit their joining reports physically to their concerned Drawing and Disbursing Officers (DDOs) within a period of 21 days from the date of issuance of this order and in case of failure of any appointee to join within the stipulated period, his/her appointment shall be deemed to have been cancelled abinitio without any further notice.

- B) The appointee(s) shall be allowed to join by the concerned Drawing and Disbursing Officers (DDOs) only on production of the following certificates in original:-
  - Academic/Technical Qualification Certificates.
  - ii. Matriculation/Date of Birth Certificate.
  - iii. Health Certificate issued by the Standing Medical Board.
  - iv. Domicile Certificate issued by the Competent Authority.
  - v. That if the candidate has taken loan for self-employment from DIC/Employment Department, to be ascertained from the District Industries Centre (DIC) and District Employment & Counseling Centre of the domicile District, he/she shall relinquish the proprietorship of unit/enterprise and also stakes, if any, in such self-employment unit/enterprise before joining the Government service. He/She shall be required to repay the entire loan liability in suitable EMIs to be worked out by the DDO concerned from his/her salary. DDO concerned shall obtain an affidavit from the concerned appointee regarding both relinquishment of proprietorship and stakes, if any, in such a self employment unit/enterprise and recovery to be made and also personally monitor its recovery."
  - vi. Relevant category certificate(s), (in case of candidates belonging to reserved categories).
  - vii. Any other certificates/documents as required under rules/norms.
- C). The appointee(s) shall give an undertaking duly attested by the First Class Judicial Magistrate in the shape of an affidavit to the effect that, if on verification of his/her Qualification/Date of Birth/Reserved Category Certificates from the concerned issuing authorities are found/proved to be fake or forged, the appointment shall be deemed to have been cancelled ab-initio without further notice and the legal action as warranted under rules shall be initiated against the candidate.
- D) The salary of the appointees shall not be drawn and disbursed to him/her unless the satisfactory reports in respect of (B) above are received in his/her favour.
- E) The appointees shall be on probation for a period of two years.
- F) The appointment of the candidates shall be governed by the "New Pension Scheme" as notified vide SRO-400 of 2009 dated 24.12.2009.
- G) The inter-se-seniority of the appointees shall be drawn in accordance with the merit secured by these appointees in the selection list prepared by the J&K Public Service Commission.
- H) The appointee(s) shall not be allowed to continue with PG/ tenures of Senior Residency/ Jr. Residency/ Registrarship/ Demonstratorship/ Tutorship/ Fellowship etc. and they will have only one choice either to opt for appointment or opt out and go for such higher study/training course, in which case candidates from the waiting list will be considered for appointment.

 The appointment of the candidates shall be subject to outcome of the writ petition (s), if any, pending

- J) The appointees shall give an undertaking duly attested by the First Class Judicial Magistrate in the shape of an affidavit to the effect that:
  - he/she shall abide by all the terms & conditions as laid down in this appointment order.

- ii. he/she is not undergoing any higher study/training course viz. PG/tenures of Senior Residency/Jr. Residency/ Registrarship/ Demonstratorship/Tutorship/Fellowship etc and in case after joining as Medical Officer, it comes to the notice of the department that appointee is on the rolls of any Medical College (Government/Private) within or outside the UT of J&K, he/she shall be liable for criminal proceedings under relevant provisions of law and his appointment shall be deemed to have been cancelled ab-initio.
- iii. he/she shall not claim for any kind of leave, permission or exception to continue with his/her higher study/training course viz. PG/tenures of Senior Residency/ Registrarship/ Demonstratorship/ Tutorship/Fellowship etc.
- iv. he/she shall be liable for action as warranted under rules for violating any of the laid down conditions in this appointment order.

#### It is further ordered that:-

All the concerned Chief Medical Officers / Medical Superintendents/Block Medical Officers/DDO's shall ensure that appointee Medical Officer shall attend duties as per his/her specific place of posting without any change/alteration in their postings by way of deployments or internal arrangements failing which disciplinary proceedings shall be initiated against such concerned Chief Medical Officers/ Medical Superintendents/ Block Medical Officers/ DDO's including appointee Medical Officer.

All the concerned Drawing & Disbursing Officers of Health & Family Welfare Department shall submit categoric report/details of appointees who fail to join physically within the stipulated time period immediately after expiry of 21 days to the Administrative Department concerned Directorates. Besides, attendance alongwith documentary evidence in respect of the appointees, who joined physically, shall be submitted at the end of every month to the Administrative Department concerned Directorates and in case any discrepancy of facts is brought to the notice of Administrative Department, action as warranted under rules, shall be taken against such DDO(s).

The Director SKIMS Soura, Srinagar, Principal, SKIMS Medical College, Bemina, Srinagar and all the concerned Principals of Government Medical College(s) of UT of J&K, shall ensure that appointee Medical Officer opts for only one full time assignment i.e either to continue with his/her higher study/training course or alternatively on the appointed post of Medical Officer, to avoid parallel engagements.
